The project seeks to address the economic marginalization of youth with disabilities and refugee youth by facilitating their integration into horticulture and sunflower value chains, thus fostering inclusive growth and sustainable development.

Tanzania's agriculture sector holds immense potential for economic empowerment, yet youth with disabilities and refugees face systemic barriers to participation. Legal constraints, limited access to resources, and inadequate vocational skills hinder their engagement in agriculture. With the unemployment rate for youth at 10% (ages 15-24) and 8% (ages 25-29), particularly acute in rural areas, the need for inclusive employment solutions is urgent. This project seeks to address these challenges, with Disability Relief Services Tanzania (DRST) serving as the implementing partner.
